## **Committee Reports:**

- Loan Review Committee: Matt Siver offered a portfolio overview including several loans being closed on and several repaid indicating a solid portfolio with outreach for additional lending in 2021.
- Education and Outreach Committee: nothing to report
- Audit/Finance Committee
  - 2021 Budget: Eric Virkler presented the 2021 budget. Projections are similar to 2020. Eric Virkler moved to approve the budget, Cheyenne Steria seconded, and the budget passed with no dissension.
  - ESD SBRLF Memorandum: Michelle Capone presented some details about the NCA's Empire State Development Small Business Revolving Loan Fund. Because of a combination of low interest rates, defaulted loans, and the short time window on the loan renewal process, the total net gain from the fund does not support keeping the full amount that has been loaned to the NCA. Discussion revealed that the AEDC faces a similar situation. Eric Virkler moved the finance committee recommendation of returning \$500,000 of the ESD SBRLF to New York State, and continuing to work with the remaining funds on short term loans. Brian Gladwin seconded, and the motion passed unanimously.
