- II. Loan Review Request War Cannon Spirits, LLC. request for \$200,000; 1 year at 5%. M. Siver presented the request and outlined the major changes to the project such as; the operating company changing from War Canoe Spirits, LLC to War Cannon Spirits, LLC, the addition of a second production location at 30 Commerce Drive in Ticonderoga NY due to infrastructure factors outside of the businesses control at their flagship location at 2840 NYS Route 9N in Crown Point, NY. Overall the committee agreed that the changes to the project made sense and R. Pancoe indicated that he isn't directly working on the project but he was aware of the project and would abstain, although he supported the project. Carol Calabrese was the loan review committee sponsor for the project and indicated that the summary of the changes for this loan request were accurate and she was very supportive of the project as it is in its final stages.
