✓ Successful Education and Outreach in Economic Development:

NCA Advocacy Action	Results
The NCA <u>supports</u> the Governor's continued promotion of the regional council process and <u>supports</u> the additional executive budget proposals for \$750 million for Round VII of the REDC Competition; and \$100 million for Downtown Revitalization Program.	The 2017-18 Enacted budget extended the regional council process. It included \$100 million for the Downtown Revitalization Initiative.
The NCA <i>supports</i> the Governor's Executive Budget proposal to invest in life science initiatives.	The 2017-2018 Enacted budget provided \$320 million toward the \$620 million Life Sciences Initiative and two new tax incentives worth \$200 million over 10 years to be funded from the existing Excelsior Jobs Program allocation.
The NCA <i>supports</i> the Governor's Executive Budget proposal to invest in infrastructure across NYS to attract economic development projects.	The 2017-2018 Enacted budget \$200 million for the New York Works Economic Development Fund.
The NCA <u>supports</u> funding to Technology Development Organizations (TDOs) and Manufacturing Extension Programs (MEPs)	The 2017-2018 Enacted budget continued funding to these programs.
The NCA <u>recommends</u> \$75 million in funding be provided to fund Round V of RESTORE NY.	The 2017-2018 Enacted budget provided \$80 million in funding for Round V.

The requirement to create additional jobs was removed.
