FUELING BUSINESS GROWTH

The North Country Alliance (NCA) saw another strong year for lending in 2024. Six loans closed in 2024 totaling \$730,726 in loan funds, while leveraging over \$7 million in investment, and creating or retaining 55 full-time equivalent jobs. The projects ranged from the acquisition of a marina in Jefferson County, to the expansion of a diesel engine repair business in Lewis County, to a manufacturer of probiotic-rich fermented foods in Essex County.

The NCA works very closely with lenders, including banks, credit unions, non-bank lenders, and other economic development organizations to help fill the funding gap to ensure eligible projects receive the funding needed to be successful.

The NCA provided bridge financing to two additional projects in 2024. These projects were located in St. Lawrence and Lewis Counties. In these two cases, the businesses received state grants that are to be paid to the business upon completion of the work. This means, the businesses required a loan to cover, or bridge, the state grant funds until the work was completed and paid to the business by the state. Traditional lenders, like banks, do not typically lend to bridge state grants. Therefore, entities like the NCA have been filling this funding gap, where it can, to help businesses benefit from state grants.

A VOICE FOR GROWTH

As its mission states, the NCA advocates on behalf of the North Country. The Education and Outreach Committee is comprised of members and meets to discuss the issues facing businesses and communities across the North Country. Annually, an Education and Outreach Agenda is drafted to share with elected officials to make them aware of these concerns, but to also make them aware of what is working.

In 2024, the Committee identified continued support for legislation that would provide quality, affordable housing for all populations, investment in workforce development and childcare programs, continued investment in rural broadband initiatives and rural infrastructure projects like water, sewer, and electric transmission facilities. The NCA is also concerned about any future prison closures, as several have already been closed in the North Country, and have yet to be redeveloped. These closures have a negative impact on the communities in which they are located. The NCA was very grateful to the state for its continued investment in capital projects at the Olympic Regional Development Authority in Lake Placid.

SHARING OUR EXPERIENCES

Key to the organization's long term success is its collaboration among members. The NCA strives to bring members together to share information including best practices and common issues.

Twice a year, the NCA holds face-to-face membership meetings at various locations throughout the seven-county region. In 2024, the NCA held its annual meeting in June in Lake Placid at the Olympic Ski Jump Complex where members learned more about the Olympic Regional Development Authority (ORDA) and its impacts on the region. ORDA was created to manage the facilities used during the 1980 Olympic Winter Games at Lake Placid, and also operates Whiteface Mountain ski area, Gore Mountain ski area, Belleayre Mountain, and the Olympic Jumping Complex and Sports Complex.

The NCA's Fall Forum was held in Massena, where then Administrator Adam Tindall-Schlicht, presented on the Great Lakes St. Lawrence Seaway Development Corporation. The organization



is a wholly owned government corporation created by statue in 1954 to construct, operate and maintain that part of the St. Lawrence Seaway between the Port of Montreal and lake Erie, within the territorial limits of the United States.

BRIDGING GRANTS

In 2024, the NCA provided \$200,000 to Tug Hill Artisan Roasters, LLC to help bridge a RESTORE NY grant that the business received. With the Development Authority of the North Country, a total funding package of \$400,000 was provided to the business to help cover costs until they are able to receive the funds from NYS. Without programs like the NCA, these projects would not be able to occur.

BUSINESS SPOTLIGHT

In 2024, the NCA closed on a \$150,000 loan to Carbone's Harbor Realty, LLC, in partnership with Watertown Savings Bank, to facilitate the purchase of the Henchen Marina in Henderson Harbor, NY. Under the name Henchen at Carbone's Waterside Marina, this gem will be owned and operated by Steve Carbone, along with business partners David and Alison LaSpada.



Nestled on Henderson Harbor, the marina features six covered boat slips, six cozy cabins, and a four-bedroom apartment above the retail space. The team has plans to revitalize the marina in the years to come.

EXPANDING THE LOAN FUND

The NCA has been the beneficiary of several U.S. Department of Agriculture Intermediary Relending Program (IRP) loans. On December 22, 2023, the NCA closed on its 6th loan of \$750,000, however the real impact was felt in 2024 when the organization drew down \$500,000 to fund several projects. The loan is a 30 year loan at 1% with principal and interest payments annually to USDA. Since the organization's inception, the NCA has successfully paid back \$2 million to USDA for its IRP loans 1 and 2. Without USDA's support, the NCA would not be able to provide the financing needed to help see businesses in the North Country succeed.

Income Statement:

- Income and expenses are charged to funding sources and restricted, unless otherwise unrestricted by the regulatory agency for administrative expenses.
- Primary income is interest income from repayment on loans.
- Primary expenses are the portfolio management fee, interest paid on loans, and insurances.
- Primary funding sources: Empire State Development Small Business Revolving Loan Fund (ESD SBRLF), Urban Development Corporation (UDC), U.S. Department of Agriculture Intermediary Relending Program (USDA IRP), and U.S. Department of Agriculture Rural Business Enterprise Grant Program (USDA RBEG)
- The Audit and Finance Committee met throughout the year to review the Corporation's financial performance.
